REQUEST FOR PROPOSALS (RFP): MECHANICAL AND ELECTRICAL WORKS FOR FRANCISTOWN GRS DEPOT EXPANSION PHASE | - **BOL/2022-23/09**

Botswana Oil Limited (BOL) serves as the Botswana Government's transformation agent in the oil and gas industry and is mandated to ensure security of supply and efficiency of petroleum products in the country, manage state owned strategic fuel reserve facilities, strategic stocks as well as bulk storage and distribution. Wholly owned by the Botswana Government, the entity is also responsible for facilitating the participation of citizen companies in the petroleum sector. BOL is registered under the Companies Act and started operating in July 2013.

INVITATION TO TENDER

BOL invites 100% citizen-owned qualified mechanical and electrical works companies and/or Joint ventures registered with the Public Procurement Asset Disposal Board (PPADB) to bid for the provision of mechanical and electrical works for the Francistown GRS Depot Expansion Phase 1.

REQUIREMENTS

This tender is reserved for qualified, PPADB registered, 100% Citizen owned companies and/or Joint Ventures/Associations between 100% Citizen owned companies. Specialist work can be subcontracted to a non-citizen company to the value not exceeding 40% of the total tender price. Tenderers are required to be registered with PPADB in the following categories:

Mechanical Works: PPADB Code 08 (Mechanical Engineering Works, Grade E), Subcodes 01 (01 Air conditioning/Refrigeration systems), 02 (Solar water heating), 04 (Fire suppression systems), 06 (Liquid petroleum gas installations and equipment), 08 (Steam and boiler systems), 10 (General fabrication and machine shop services) and 11 (Pumps and munchers)

Electrical Works: PPADB Code 02 (Electrical Engineering Works, Grade E), Subcodes 01 (Electrical Installations), 02 (High voltage reticulation), 04 (Automated machinery and control systems), 06 (Fire detection systems), 07 (Security systems installations) and 08 (Radio/Telemetry)

Note: In case of a Joint Venture/Association if any, partners must submit the required PPADB registration certificate in line with the works allocated to them including subcontracted parties. The Joint Venture/Association including subcontracted parties must satisfy all the required PPADB codes between themselves.

Registration will be restricted to one (1) person per company and will close at 0930hrs. Late comers will not be allowed to register. Tenderers' personnel attending the compulsory site visit must bring their own safety equipment comprising steel toe boots, hard hats, reflective overalls. Access to the site shall not be permitted without this equipment. The number of representatives for each prospective bidder shall be limited to two (2) people and COVID-19 Protocols must be observed throughout the site visit.
